Gentlemen

I attach a specimen draft intelligence report ('report') prepared for State Security Agency Director-General Thembisile Majola to submit (after editing at will) to President Cyril Ramaphosa.

It chiefly concerns aggravated judicial corruption in the higher courts, all documented, still unresolved more than six years since it was reported, and it proposes a conciliated resolution in the national interest.

Ms Majola ignored the report.

So did Minister in the Presidency for State Security Khumbudzo Ntshavheni, to whom I subsequently sent it as well.

Accordingly, as contemplated both in the report and in my covering letters, I hereby give notice that on Monday 21 August 2023, I will commence distributing the report to all the foreign embassies and other interested parties enumerated in its paragraph 66, starting with our country's BRICS partners, the BRICS+ states, and other nations invited to the BRICS summit opening the next day.

Unless requested by the Office of the Presidency not to do so.

I trust therefore that this matter will be given immediate serious attention.

I hope to hear from you by 10 am on the above-mentioned date, failing which I will proceed to escalate the matter internationally as said. All delivery records and responses will be posted at corrupt-judges.co.za/SSA.
